This fund update was first made publicly available on 3 May 2017.

What is the purpose of this update?

This document tells you how the Alternative Investments Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Alternative Investments Fund was established with the aim of providing capital growth over the long term by investing in vehicles such as hedge funds, absolute return funds, venture capital funds and private equity funds. The fund is in the process of termination and is closed to all further investment.

How has the fund performed?

The market index return reflects the benchmark index returns for the relevant period. Effective from 1 April 2016 the benchmark index for this fund was changed to the HFRX Global Hedge Fund Index (100% hedged on a before tax basis to NZD) which is considered to better reflect the nature of the fund's assets. Prior to this date the S&P/NZX Bank Bills 90-Day Index was used.²

What are the risks of investing?

Risk indicator for the Alternative Investments Fund.¹




The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

This risk indicator is not a guarantee of a fund's future performance. The risk indicator is based on the returns data for the five years to 31 March 2017. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

Annual return graph



This shows the return after fund charges and tax for each complete year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 March 2017.

Important: This does not tell you how the fund will perform in the future. Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$233 (that is 2.33% of his initial \$10,000). Jason did not pay anything in other charges. This gives Jason a total return after tax of \$233 for the year.

Notes

1. The risk category for each fund is calculated based on the volatility of past returns over five years and this does not represent a full investment cycle. The output may be different if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on was one of unusually low or unusually high volatility the risk category presented in a fund update may not reflect the fund's future volatility.
