- Financial statements and auditor's report were dated 25 July 2017 and were lodged with the Registrar on 28 July 2017.

Changes relating to the Scheme

The following material changes occurred to the Scheme during the year ending 31 March 2017:

Changes to the governing document and SIPO

The Scheme transitioned to the Financial Markets Conduct Act 2013 (FMCA) regime on 9 September 2016. Changes to the Scheme's trust deed (Trust Deed) were required to ensure the Scheme's compliance with the FMCA and Financial Markets Conduct Regulations 2014.

A new Statement of Investment Policy and Objectives (SIPO) was published on 9 September 2016 as part of the Scheme's transition to the FMCA.

Changes to the terms of offer of the managed investment products

On 23 August 2016 the BTNZ Board approved the termination of the Premium Investment Funds Alternative Investments Fund (AIF). This decision followed the notification from Advance Asset Management Limited of the termination of the Advance Alternative Strategies Multi-Blend Fund in which AIF invested indirectly. AIF received a number of payments in respect of this indirect investment with the final payment received on 16 June 2017.

The Alternatives Strategies Fund was launched on 19 September 2016.

Changes to the nature or scale of related party transactions

There were no material changes to the nature or scale of related party transactions.

Related party transactions at arm's length

All related party transactions were conducted on arm's-length terms and enacted on standard commercial terms.
