## What is the purpose of this update?

This document tells you how the Growth Trust<sup>1</sup> has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# **Description of this fund**

The Growth Trust aims to provide higher returns over the long term. The fund invests primarily in growth assets but also has an allocation to income assets. Volatility is expected to be the highest of the funds in the Westpac Active Series.

# What are the risks of investing?

Risk indicator for the Growth Trust.<sup>2</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




#### Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$972 (that is 9.72% of his initial \$10,000). Jason did not pay anything in other charges. This gives Jason a total return after tax of \$972 for the year.

#### Notes

- 1. The fund is offered under the Westpac Active Series as the Westpac Active Growth Trust (Growth Trust).
- 2. The risk indicator for the fund is calculated based on the volatility of past returns over five years, which is not a full investment cycle. In some cases the output may be different if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on was one of unusually low or unusually high volatility the risk indicator presented in a PDS (or any fund update) may provide a less reliable indication of the potential future volatility of a fund. There has been unusually low volatility experienced throughout the period used to calculate the risk indicator. The fund has previously exhibited medium to high volatility and historic fund updates for this fund (to 31 March 2017) indicate the fund had a corresponding risk category of 4. Accordingly, the current indicator for this fund is lower than we consider is appropriately representative of the funds potential future volatility.
- 3. The return on the composite index has been used in the following ways, because there is no appropriate market index for the exposure to Other assets: in the How has the fund performed? table, and in the Annual Return Graph Index bars, applicable from 1 April 2016. A composite index may be a less reliable indicator of performance than an appropriate market index. The return for the peer group index used in the composite index and reflected in the table and the bar graph is net of fund charges and trading expenses (if any) but before tax.
- 4. For further information on each of the asset classes refer to the PDS and the SIPO.
- 5. "Other" represents investments in hedge funds.
- 6. "Other" is comprised of Alternative Investments, and can include hedge funds and absolute return funds.
- 7. The top 10 investments have been calculated excluding cash and cash equivalents held for operational and hedging purposes.
