This fund update was first made publicly available on 3 May 2023.

#### What is the purpose of this update?

This document tells you how the Moderate Trust has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

The Moderate Trust aims to provide moderate returns over the medium term. The fund has a higher benchmark allocation to income assets than to growth assets. Volatility is expected to be higher than the Conservative Trust but lower than the Balanced Trust in the Westpac Active Series.

#### What are the risks of investing?

Risk indicator for the Moderate Trust.1



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


#### How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.


### Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason incurred a loss after fund charges were deducted of -\$226 (that is -2.26% of his initial \$10,000). Jason did not pay anything in other charges. This gives Jason a total loss after tax of -\$226 for the year.

#### **Currency Hedging**

Some of the asset classes in the fund have exposure to foreign currencies. As at 31 March 2023, the actual currency hedging is as follows:

- International fixed interest 97% hedged (benchmark 100%)
- Australasian equities 67% hedged (benchmark 70%)
- International equities 51% hedged (benchmark 51%)
- Listed property (Australasian) 100% hedged (benchmark 100%)

#### **Notes**

- 1. The risk indicator for the fund is calculated based on the volatility of returns over the past five years, which may not be a full investment cycle. In some cases the risk indicator might differ if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years.
