## What is the purpose of this update?

This document tells you how the Corporate Bond Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The Corporate Bond Fund aims to provide capital growth over the short to medium term by investing primarily in a range of New Zealand fixed interest assets issued by corporate entities.

Small differences in fees and charges can have a big impact on your investment over the long term.

## Example of how this applies to an investor

Jason had $\$ 10,000$ in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of $\$ 43$ (that is $0.43 \%$ of his initial $\$ 10,000$ ). Jason did not pay anything in other charges. This gives Jason a total return after tax of $\$ 43$ for the year.

## Notes
