This fund update was first made publicly available on 31 July 2023.

#### What is the purpose of this update?

This document tells you how the International Diversified Bond Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

The International Diversified Bond Fund aims to provide capital growth over the short to medium term by investing primarily in a range of international fixed interest assets. The primary areas of investment are North America, United Kingdom, Europe and the Asia-Pacific region.

#### What are the risks of investing?

Risk indicator for the International Diversified Bond Fund.<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


#### How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.


#### Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$46 (that is 0.46% of his initial \$10,000). Jason did not pay anything in other charges. This gives Jason a total return after tax of \$46 for the year.

#### **Currency Hedging**

The fund has exposure to foreign currencies. As at 30 June 2023, the actual currency hedging for the fund's foreign currency exposure was 96% hedged (benchmark 100%).

#### Notes

- 1. The risk indicator for the fund is calculated based on the volatility of returns over the past five years, which may not be a full investment cycle.
