#### What is the purpose of this update?

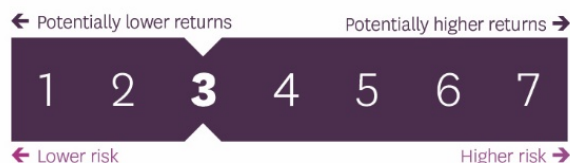
#### Description of this fund

The Dynamic Portfolio aims to provide higher returns over the long term. The Dynamic Portfolio invests primarily in growth assets but also has an allocation to income assets. Volatility is expected to be the highest of the Portfolios in the Westpac Retirement Plan.

#### What are the risks of investing?

Risk indicator for the Dynamic Portfolio.<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

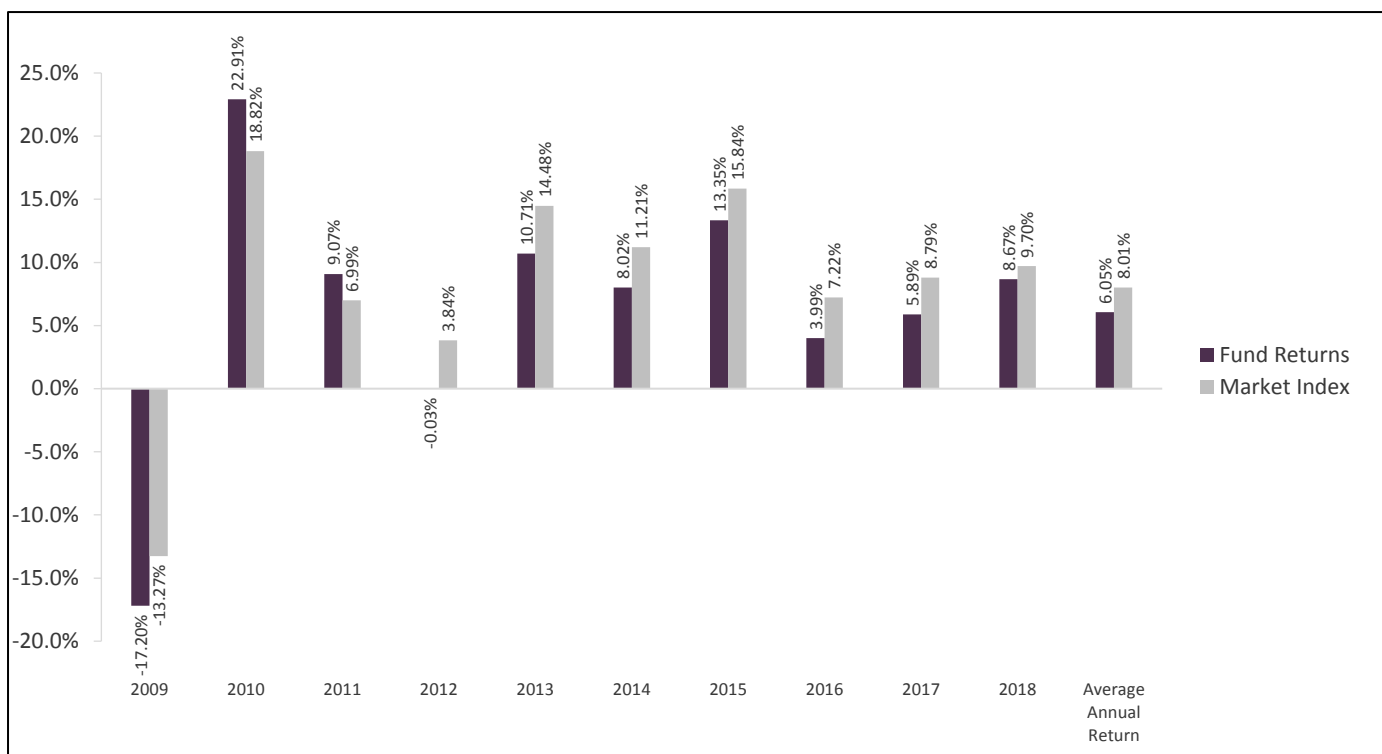
#### How has the fund performed?

This shows the return after fund charges and tax for each of the last 10 complete years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 March 2018.

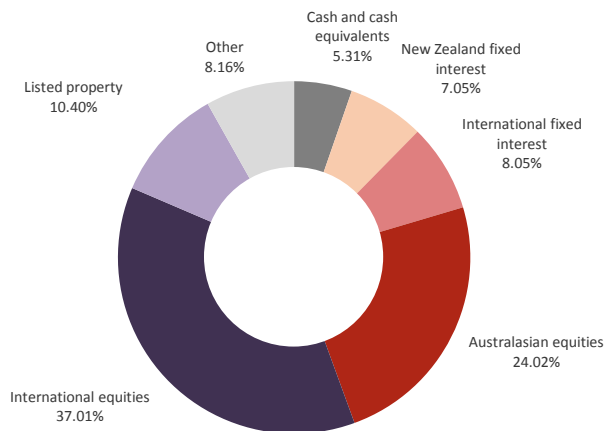
## Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$867 (that is 8.67% of his initial \$10,000). Jason also paid \$55 in other charges. This gives Jason a total return after tax of \$812 for the year.

## Notes

1. The risk category for the fund is calculated based on the volatility of past returns over five years and this does not represent a full investment cycle. The output may be different if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on was one of unusually low or unusually high volatility the risk category presented in a fund update may not reflect the fund's future volatility.
2. Other charges are the Administration fee, which is the total of the weekly fixed dollar charges for membership in the Westpac Retirement Plan. You will pay this fee only once each week even if you are invested in multiple funds within the Westpac Retirement Plan. This fee may be waived if you have an Account balance of more than \$12,000.

4. "Other" represents investments in hedge funds.
5. "Other" is comprised of Alternative Investments, and can include hedge funds and absolute return funds.
6. The top 10 investments have been calculated excluding cash and cash equivalents held for operational and hedging purposes.
