Fund Update for the quarter ended:

This fund update was first made publicly available on 13 February 2020.

What is the purpose of this update?

This document tells you how the CPP Fund No. 3 has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited¹ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The CPP Fund No. 3 aims to protect each member's initial invested capital on the maturity of the fund. The assets of the fund are dynamically allocated between growth assets and zero coupon bonds or deposits according to prescribed asset allocation rules. The fund is closed to further investment and is currently expected to mature on or about 30 September 2020.

What are the risks of investing?

Risk indicator for the CPP Fund No. 3.2



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating.

This risk indicator is not a guarantee of a fund's future performance. The risk indicator is based on the returns data for the five years to 31 December 2019. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

It should be noted that whilst the risk indicator may reflect a higher rating based on the returns data, this fund is designed to protect each member's initial invested capital upon maturity.


How has the fund performed?

This shows the return after fund charges and tax for each complete year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2019.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$2,396 (that is 23.96% of his initial \$10,000). Jason also paid \$27 in other charges. This gives Jason a total return after tax of \$2,369 for the year.

Currency Hedging

The fund has exposure to foreign currencies. As at 31 December 2019, the actual currency hedging is as follows:

- Australasian equities 100% hedged (benchmark 100%)
- International equities 67% hedged (benchmark 69%)

Notes

- 1. BT Funds Management (NZ) Limited is the scheme provider and Westpac New Zealand Limited is the distributor of the Westpac KiwiSaver Scheme.
- 2. The risk indicator for the fund is calculated based on the volatility of past returns over five years, which is not a full investment cycle. In some cases the output may be different if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on was one of unusually low or unusually high volatility the risk indicator presented in a fund update may provide a less reliable indication of the potential future volatility of a fund.
- 3. The amounts specified include GST, where applicable.
- 4. Membership fees are the monthly fixed dollar charges for membership in the Westpac KiwiSaver Scheme. You will pay this fee only once each month even if you are invested in multiple funds within the Westpac KiwiSaver Scheme.
- 5. If the value of the growth assets of this Capital Protection Plan Fund falls below certain predetermined levels, BT Funds Management (NZ) Limited will adjust the asset allocation of the fund by investing some or all of the assets of the fund in zero coupon bonds or deposits issued by the capital protection provider, Westpac Banking Corporation (New Zealand Branch).

- 7. The top 10 investments have been calculated excluding cash and cash equivalents held for operational and hedging purposes.
