

# Westpac KiwiSaver Scheme

## Conservative Fund

### Fund Update for the quarter ended:

**30 September 2022**

This fund update was first made publicly available on 31 October 2022.

#### What is the purpose of this update?

This document tells you how the Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited<sup>1</sup> prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Conservative Fund aims to provide stable returns over the short to medium term. The fund invests primarily in income assets but also has a 25% benchmark allocation to growth assets. Volatility is expected to be higher than the Defensive Conservative Fund but lower than the Moderate Fund in the Westpac KiwiSaver Scheme.

#### What are the risks of investing?

Risk indicator for the Conservative Fund.<sup>2</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

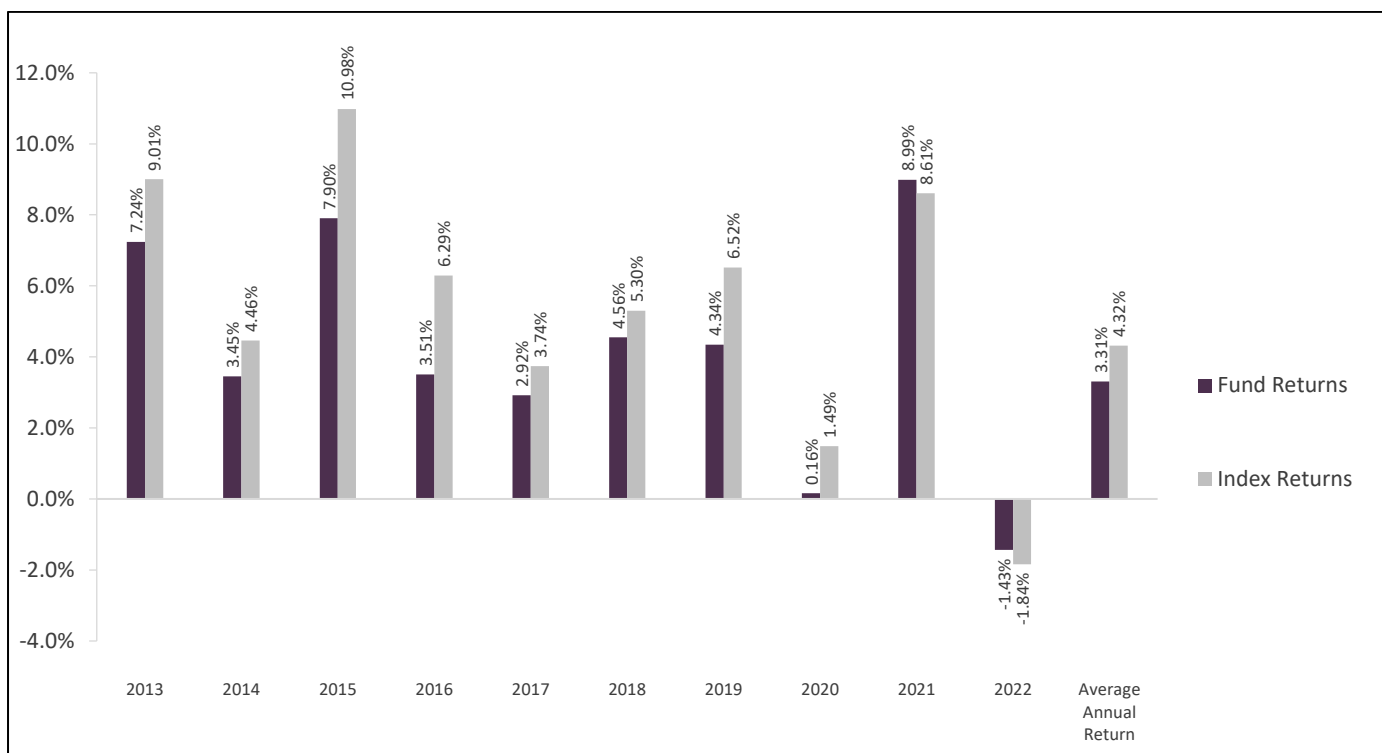
#### How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

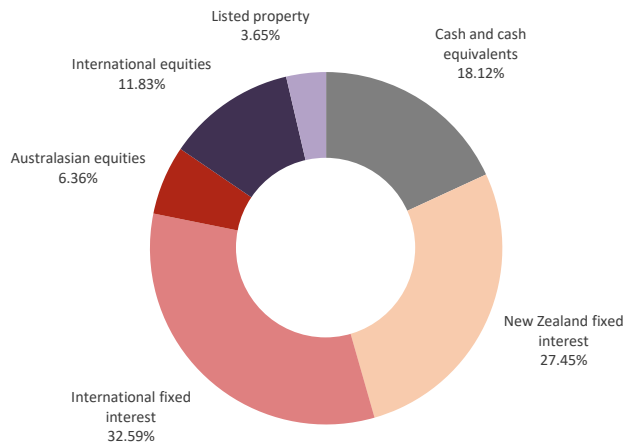
### Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason incurred a loss after fund charges were deducted of -\$749 (that is -7.49% of his initial \$10,000). Jason also paid \$6 in other charges. This gives Jason a total loss after tax of -\$755 for the year.

## Currency Hedging

Some of the asset classes in the fund have exposure to foreign currencies. As at 30 September 2022, the actual currency hedging is as follows:

- International fixed interest – 100% hedged (benchmark 100%)
- Australasian equities – 70% hedged (benchmark 70%)
- International equities – 53% hedged (benchmark 51%)
- Listed property (Australasian) – 102% hedged (benchmark 100%)
- Listed property (International) – 140% hedged (benchmark 139%)

## Notes

1. BT Funds Management (NZ) Limited is the scheme provider and Westpac New Zealand Limited is the distributor of the Westpac KiwiSaver Scheme.
2. The risk indicator for the fund is calculated based on the volatility of returns over the past five years, which may not be a full investment cycle. In some cases the risk indicator might differ if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on has had unusually low or high volatility the risk indicator presented in this fund update (or the PDS) may provide a less reliable indication of a fund's potential future volatility.

The return on the composite index, which was used up until 28 September 2021, has been used in the following ways, because there was no appropriate market index for the exposure to Other assets: in the How has the fund performed? table, and in the Annual Return Graph Index bars, applicable from 1 April 2016. The return for the peer group index used in the composite index and reflected in the table and the bar graph is net of fund charges and trading expenses (if any) but before tax.
