This fund update was first made publicly available on 13 February 2020.

#### What is the purpose of this update?

This document tells you how the Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited¹ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

The Conservative Fund aims to provide stable returns over the short to medium term. The fund invests primarily in income assets but also has an allocation to growth assets. Volatility is expected to be higher than the Default Fund but lower than the Moderate Fund in the Westpac KiwiSaver Scheme.

#### What are the risks of investing?

Risk indicator for the Conservative Fund.<sup>2</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


#### How has the fund performed?

This shows the return after fund charges and tax for each of the last 10 complete years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 December 2019.

<sup>\*</sup>Following a decrease in the management fee and the other management and administration charges, the Manager estimates that the total fund charges for the next scheme year will reduce to 0.64% of the fund's net asset value.

Small differences in fees and charges can have a big impact on your investment over the long term.


#### Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$787 (that is 7.87% of his initial \$10,000). Jason also paid \$27 in other charges. This gives Jason a total return after tax of \$760 for the year.

#### **Currency Hedging**

Some of the asset classes in the fund have exposure to foreign currencies. As at 31 December 2019, the actual currency hedging is as follows:

- International fixed interest 98% hedged (benchmark 100%)
- Australasian equities 100% hedged (benchmark 100%)
- International equities 67% hedged (benchmark 69%)
- Listed property (Australasian) 99% hedged (benchmark 100%)
- Listed property (International) 131% hedged (benchmark 139%)
- Other 100% hedged (benchmark 100%)

#### **Notes**

- 1. BT Funds Management (NZ) Limited is the scheme provider and Westpac New Zealand Limited is the distributor of the Westpac KiwiSaver
- 2. The risk indicator for the fund is calculated based on the volatility of past returns over five years, which is not a full investment cycle. In some cases the output may be different if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on was one of unusually low or unusually high volatility the risk indicator presented in a PDS (or any fund update) may provide a less reliable indication of the potential future volatility of a fund.
- 3. The return on the composite index has been used in the following ways, because there is no appropriate market index for the exposure to Other assets: in the How has the fund performed? table, and in the Annual Return Graph Index bars, applicable from 1 April 2016. A composite index may be a less reliable indicator of performance than an appropriate market index. The return for the peer group index used in the composite index and reflected in the table and the bar graph is net of fund charges and trading expenses (if any) but before tax.

- 5. Membership fees are the monthly fixed dollar charges for membership in the Westpac KiwiSaver Scheme. You will pay this fee only once each month even if you are invested in multiple funds within the Westpac KiwiSaver Scheme.

- 7. "Other" represents investments in hedge funds.
- 8. "Other" is comprised of Alternative Investments, and can include hedge funds and absolute return funds.
