This fund update was first made publicly available on 13 February 2024.

What is the purpose of this update?

This document tells you how the Default Balanced Fund¹ has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited² prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Default Balanced Fund aims to provide moderate to medium returns over the medium to long term. The fund has an equal target allocation to growth assets and income assets. Volatility is expected to be higher than the Moderate Fund but lower than the Balanced Fund in the Westpac KiwiSaver Scheme.

What are the risks of investing?

Risk indicator for the Default Balanced Fund.34



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


The market index return reflects a composite of benchmark index returns, weighted for the fund's target asset allocation. The benchmark indices used for each asset class are defined in the Statement of Investment Policy and Objectives (SIPO).

Effective from 2 October 2023, there has been a change to the benchmark provider for international equities, which is an asset class within the market index. This change allows for enhanced internal monitoring.

Effective from 1 November 2023, there has been a change to the benchmark for international fixed interest, which is an asset class within the market index. This change provides additional diversification to the benchmark and reflects changes made to the asset class strategy.

This shows the return after fund charges and tax for each complete year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2023.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$898 (that is 8.98% of his initial \$10,000). Jason did not pay anything in other charges. This gives Jason a total return after tax of \$898 for the year.

Currency Hedging

Some of the asset classes in the fund have exposure to foreign currencies. As at 31 December 2023, the actual currency hedging is as follows:

- International fixed interest 99% hedged (benchmark 100%)
- Australasian equities 64% hedged (benchmark 70%)
- International equities 53% hedged (benchmark 51%)
- Listed property (Australasian) 96% hedged (benchmark 100%)
- Listed property (International) 136% hedged (benchmark 139%)

Notes

- 1. The Default Balanced Fund was available for investment from 1 December 2021.
- 2. BT Funds Management (NZ) Limited is the scheme provider and Westpac New Zealand Limited is the distributor of the Westpac KiwiSaver Scheme.
- 3. The risk indicator for the fund is calculated based on the volatility of returns over the past five years, which may not be a full investment cycle. In some cases the risk indicator might differ if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on has had unusually low or high volatility the risk indicator presented in this fund update (or the PDS) may provide a less reliable indication of a fund's potential future volatility.
- 4. As the fund has not been in existence for five full years, its risk indicator has been calculated using market index returns as well as actual returns. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. Market index returns have been used for the period from January 2019 to December 2021.
- 5. The amounts specified include GST, where applicable.

- 7. For the reporting of the Actual investment mix, cash and cash equivalents held for operational and hedging purposes at an asset class level (in the underlying funds) are assigned to the asset class to which they relate.
