#### What is the purpose of this update?

This document tells you how the Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 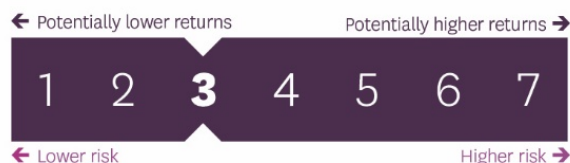
#### Description of this fund

The Growth Fund aims to provide higher returns over the long term. The fund invests primarily in growth assets but also has an allocation to income assets. Volatility is expected to be the highest of the funds in the Westpac KiwiSaver Scheme.

#### What are the risks of investing?

Risk indicator for the Growth Fund.<sup>2</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

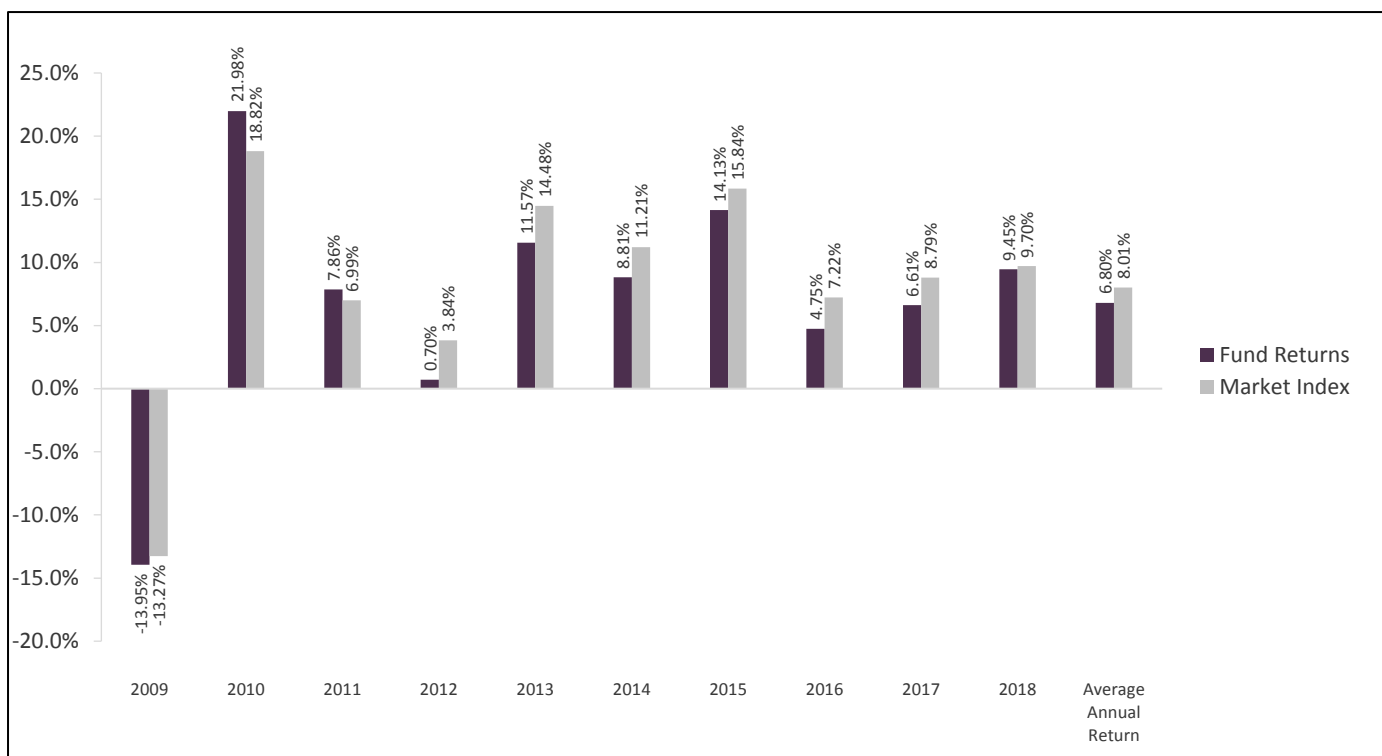
#### How has the fund performed?

This shows the return after fund charges and tax for each of the last 10 complete years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 March 2018.

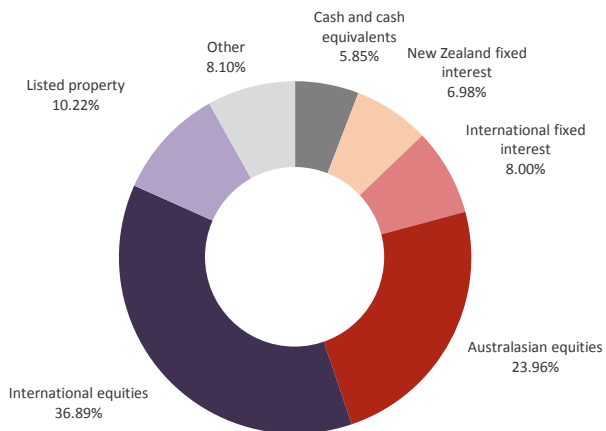
## Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$945 (that is 9.45% of his initial \$10,000). Jason also paid \$27 in other charges. This gives Jason a total return after tax of \$918 for the year.

## Notes

1. BT Funds Management (NZ) Limited is the scheme provider and Westpac New Zealand Limited is the distributor of the Westpac KiwiSaver Scheme.
2. The risk indicator for the fund is calculated based on the volatility of past returns over five years, which is not a full investment cycle. In some cases the output may be different if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on was one of unusually low or unusually high volatility the risk indicator presented in a PDS (or any fund update) may provide a less reliable indication of the potential future volatility of a fund. There has been unusually low volatility experienced throughout the period used to calculate the risk indicator. The fund has previously exhibited medium to high volatility and historic fund updates for this fund (to 31 March 2017) indicate the fund had a corresponding risk category of 4. Accordingly, the current indicator for this fund is lower than we consider is appropriately representative of the funds potential future volatility.
3. Membership fees are the monthly fixed dollar charges for membership in the Westpac KiwiSaver Scheme. You will pay this fee only once each month even if you are invested in multiple funds within the Westpac KiwiSaver Scheme.

5. "Other" represents investments in hedge funds.
6. "Other" is comprised of Alternative Investments, and can include hedge funds and absolute return funds.
7. The top 10 investments have been calculated excluding cash and cash equivalents held for operational and hedging purposes.
