What is the purpose of this update?

This document tells you how the Moderate Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited¹ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Moderate Fund aims to provide moderate returns over the medium term. The fund has a higher target allocation to income assets than to growth assets. Volatility is expected to be higher than the Conservative Fund but lower than the Default Balanced Fund in the Westpac KiwiSaver Scheme.

What are the risks of investing?

Risk indicator for the Moderate Fund.²



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



This shows the return after fund charges and tax for each complete year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2023.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$475 (that is 4.75% of his initial \$10,000). Jason did not pay anything in other charges. This gives Jason a total return after tax of \$475 for the year.

Currency Hedging

Some of the asset classes in the fund have exposure to foreign currencies. As at 30 June 2023, the actual currency hedging is as follows:

- International fixed interest 96% hedged (benchmark 100%)
- Australasian equities 68% hedged (benchmark 70%)
- International equities 50% hedged (benchmark 51%)
- Listed property (Australasian) 98% hedged (benchmark 100%)
- Listed property (International) 137% hedged (benchmark 139%)

Notes

- 1. BT Funds Management (NZ) Limited is the scheme provider and Westpac New Zealand Limited is the distributor of the Westpac KiwiSaver Scheme.
- 2. The risk indicator for the fund is calculated based on the volatility of returns over the past five years, which may not be a full investment cycle. In some cases the risk indicator might differ if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years.
