## Defensive Conservative Fund

### Fund Update for the quarter ended:

**31 December 2022**

This fund update was first made publicly available on 13 February 2023.

#### What is the purpose of this update?

This document tells you how the Defensive Conservative Fund<sup>1</sup> has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited<sup>2</sup> prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Defensive Conservative Fund aims to provide stable returns over the short to medium term. The fund invests primarily in income assets but also has a 20% benchmark allocation to growth assets. Volatility is expected to be higher than the Cash Fund but lower than the Conservative Fund in the Westpac KiwiSaver Scheme.

#### What are the risks of investing?

Risk indicator for the Defensive Conservative Fund.<sup>3</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

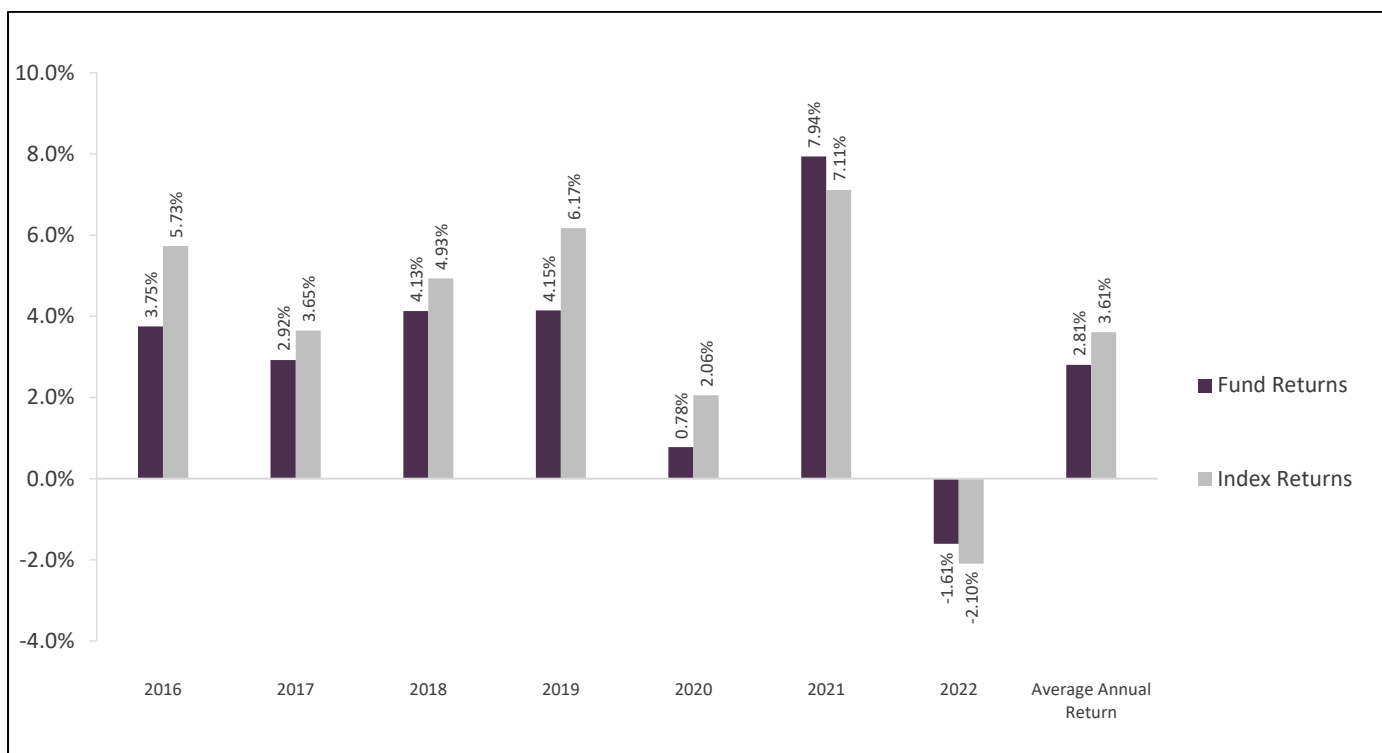
#### How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

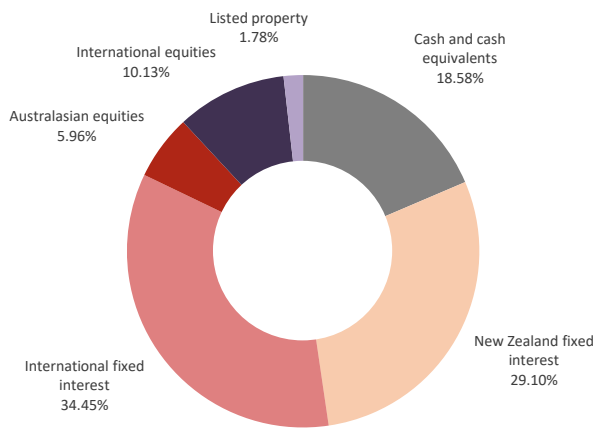
## Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason incurred a loss after fund charges were deducted of -\$587 (that is -5.87% of his initial \$10,000). Jason also paid \$6 in other charges. This gives Jason a total loss after tax of -\$593 for the year.

The top 10 investments make up 5.70% of the net asset value of the fund.<sup>8</sup>

## Currency Hedging

Some of the asset classes in the fund have exposure to foreign currencies. As at 31 December 2022, the actual currency hedging is as follows:

- International fixed interest – 98% hedged (benchmark 100%)
- Australasian equities – 69% hedged (benchmark 70%)
- International equities – 52% hedged (benchmark 51%)
- Listed property (Australasian) – 101% hedged (benchmark 100%)
- Listed property (International) – 137% hedged (benchmark 139%)

## Notes

1. The Defensive Conservative Fund (established as the Defensive Fund) was last known as the Default Fund.
2. BT Funds Management (NZ) Limited is the scheme provider and Westpac New Zealand Limited is the distributor of the Westpac KiwiSaver Scheme.
3. The risk indicator for the fund is calculated based on the volatility of returns over the past five years, which may not be a full investment cycle. In some cases the risk indicator might differ if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on has had unusually low or high volatility the risk indicator presented in this fund update (or the PDS) may provide a less reliable indication of a fund's potential future volatility.
4. The amounts specified include GST, where applicable.
5. Membership fees are the fixed dollar charges for membership in the Westpac KiwiSaver Scheme. You will pay this fee only once even if you are invested in multiple funds within the Westpac KiwiSaver Scheme. The Membership fees have been removed for all members from 28 September 2021.

7. For the reporting of the Actual investment mix, cash and cash equivalents held for operational and hedging purposes at an asset class level (in the underlying funds) are assigned to the asset class to which they relate.
8. The top 10 investments have been calculated excluding cash and cash equivalents held for operational and hedging purposes.
