
Ranking diagram as at 30 September 2017

Notes:

- Amounts shown are indicative based on the financial position of Westpac NZ and its controlled entities (*Westpac NZ Group*) as at 30 September 2017. In the event of a liquidation of Westpac NZ, the actual amounts of liabilities and equity will be different to these indicative amounts. The amounts shown are presented in millions of New Zealand dollars and may be subject to rounding adjustments.
- Secured liabilities include \$5,236 million (New Zealand dollar equivalent) of covered bonds issued by Westpac Securities NZ Limited and guaranteed by Westpac NZ. Covered bonds are an unsecured claim on Westpac NZ as guarantor but are secured over certain housing loan assets sold by Westpac NZ to Westpac NZ Covered Bond Limited. Those housing loans are recognised as assets in the consolidated financial statements of the Westpac NZ Group.

- 3 Unsubordinated and unsecured liabilities include \$3,223 million of Notes outstanding as at 30 September 2017.
